



Eurotunnel Border Pass – How does it work?



Be ready for Border crossing

To cross the border, the following information will now be required:

- **Customs** references (e.g. Transit MRN barcodes, Goods Movement Reference – GMR...)
- Mandatory **sanitary** references (SPS Sanitary or Phytosanitary if applicable)
- **Safety and security** references (e.g ENS, ICS, ECS...)

For speed and convenience, send your border data to Eurotunnel in advance

Save time and be “Brexit ready” at Pit Stops with Border Pass

According to your business model,
you can either send your data to Eurotunnel in advance or just turn up with your border references

- Specifically designed for online bookings, account holder can now send their references / barcodes in advance
- Directly associated to the booking, the Border Pass will be automatically identified at Pit Stop by the vehicle's registration numbers
- Border information will be sent automatically to the UK & FR authorities

Advantages

- Your drivers can simply pick up their loads without the need to have physically their documents
- You can get your Border Pass up to 30 minutes before travel
- Your drivers save time on our terminals as there is no need to scan their documents at the Pit Stop



1) Making an Border Pass

3 different types of Border Pass are available:

- a) Pre-notification of Border documents with barcodes for both French and UK authorities
- b) Pre-notification that the vehicle is empty or carrying only postal mail
- c) Pre-notification of ATA/TIR

In the Folkestone > Calais direction only

- 2 additional questions about phytosanitary goods and seafoods products for customers with Border documents or ATA/TIR.
- Once all the questions answered, simply “Confirm” and the Border Pass will be generated.

a) Border Pass with barcodes

> If you are crossing with a trailer, it needs to be entered accordingly

Then, you can either:

- Enter your barcodes manually; or
- Register several barcodes in one single “envelope code” by clicking on the link “[click here](#)”.
- Enter the relevant fields and finally click on “Confirm”


